### BOILER – AUTHORIZED INSPECTION AGENCY APPLICATION (AIA) INSTRUCTIONS

The application must be completed and signed by the applicant. All information provided must be typed or printed in black ink

- 1. BUSINESS NAME Provide the full name of the business to be registered (40 character maximum).
- 2. <u>FEDERAL EMPLOYER'S ID# (EIN)</u> An Employer Identification Number (EIN) is also known as a Federal Tax Identification Number and is used to identify a business entity.
- 3. MAILING ADDRESS Provide the current mailing address for the business. This is the address where we will send all mail and notices to the business. This address can be a post office box. Add the zip plus-4 to help the postal service deliver mail more efficiently and accurately.
- 4. <u>BUSINESS PHYSICAL ADDRESS</u> Provide the physical (911) address for the business. A post office box cannot be used for this address. Once the license has been issued, the business' physical address can be changed by submitting a new application.
- 5. BUSINESS PHONE NUMBER Provide the main phone number for the business, including the area code
- 6. BUSINESS FAX NUMBER Provide the main fax number, including the area code, for the business.
- 7. <u>EMAIL ADDRESS</u> Provide the business email address. Please provide an email address that can receive license information and required notices from the department. The email address provided is subject to public disclosure and will be available on the TDLR website.
- 8. <u>TYPE OF BUSINESS OWNERSHIP</u> Select the box that indicates how the business is organized. You can find a description of the various types of business structures on the <u>Secretary of State Website</u>.
