**License Instructions For A
Barber Instructor Applying for a Cosmetology Instructor License**

This application must be completed to become a Barber Instructor to instruct a person in any act of barbering pursuant to Occupational Code, Chapter 1601, Title 9.

1. **Print** your full name (Last, First Middle).
2. Indicate if you have a Social Security Number? If YES, enter your SSN in field three.
3. Provide your social security number (SSN). To be eligible for a license, the SSN disclosure is required by Section 231.302 of the Texas Family Code. Your SSN is subject to disclosure to an agency authorized to assist in the collection of child support payments. For more information regarding child support payments, contact the Texas Attorney General at:

4. Enter your Date of Birth (MM/DD/YYYY).
5. Indicate your gender.
6. Mailing Address: Enter a complete mailing address where all correspondence from the department can be mailed.

Contact information: If available, please enter a phone number, fax, and e-mail address where you may be contacted by the department.

7. Physical Address: Enter a complete physical address. P.O. Boxes are not acceptable.
8. High school diploma or equivalent. You must have a high school diploma or high school equivalency to be eligible for a license.
9. If you have ever been convicted of, or placed on deferred adjudication for, any misdemeanor or felony, other than a minor traffic violation, answer this question YES and attach a completed Criminal History Questionnaire for each conviction. The questionnaire is available on the TDLR website shown at the top of this page.
10. If you have ever had occupational license, certification or registration suspended, revoked, or denied in any state, you must answer YES to this question, and attach a completed Disciplinary Action Questionnaire for each disciplinary action. You may obtain this form at the TDLR website shown at the top of this page.
11. Select the instructor license type you currently hold.
12. Enter the license number for the instructor license selected in item 11.
13. Select the instructor license type you are requesting.
14. Read the statement of applicant, sign, and date the application.
