OFFENDER EDUCATION PROGRAM APPLICATION FOR ADDRESS CHANGE INSTRUCTIONS

Each Offender Education program desiring to change their mailing and/or physical shall provide an application for approval that shall be in compliance with 16 TAC 90 and TDLR established guidelines to change the program's addresses. The following information shall be submitted to the address listed above.

1. LEGAL NAME/DBA OF PROGRAM – Enter the official name of the program. This must be the name you are licensed under.
2. PROGRAM/PROVIDER CERTIFICATION NUMBER – Enter the license number of your school that is applying for the address change.
3. APPLICATION FEE – \$25.00 (NON-REFUNDABLE)
4. OFFENDER EDUCATION PROGRAM – Indicate program application type. A separate application will need to be submitted for each license type.
5. PROGRAM/PROVIDER MAILING ADDRESS AND CONTACT INFORMATION – Enter the mailing address, phone number, fax number, email address, and website address. This address is where the Department will mail all correspondence and may be a post office box. Provide the contact person's name, telephone, number, and email address. Email addresses are a part of the key information required to transact business with TDLR. Your email address is confidential pursuant to the Texas Public Information Act and will not be shared with the public.
6. PROGRAM/PROVIDER PHYSICAL ADDRESS – Enter the physical address. This address is the actual business location and where permanent records must be kept for auditing and inspection purposes. A post office box is not acceptable for the physical address.
7. STATEMENT OF APPLICANT – Application must be signed by the owner, officer or other authorized representative. You must print your name, sign and date the application.
