ELECTRICAL, ELECTRICAL SIGN, OR RESIDENTIAL APPLIANCE INSTALLATION CONTRACTOR NOTICE OF CHANGE AND DUPLICATE LICENSE REQUEST INSTRUCTIONS

1. BUSINESS NAME – Write your business name as it appears on your current license.
2. CONTRACTOR LICENSE NUMBER - Write your complete license number as it appears on your license issued by TDLR.
3. CONTRACTOR LICENSE TYPE - Check the license type you want to update and/or request a duplicate license.
4. DUPLICATE LICENSE REQUEST - Check this box if you want a duplicate of your contractor license. Include the \$25 fee.
5. UPDATE MY BUSINESS NAME - Write the new business name as it will appear on your license. If there is more than one business name, an assumed name certificate is required. If your business is incorporated, contact the Texas Secretary of State's office for a certificate. If your business is not incorporated, contact your local county clerk's office. List the full assumed names or DBA's for this business on the certificate of liability insurance form. The certificate of insurance must match the new name.
6. UPDATE FEDERAL ID NUMBER - Write the new federal ID number for your contractor business .
7. UPDATE MY MAILING ADDRESS - Write your new mailing address in the spaces provided. This is the address where we will send you mail. This address can be a post office box.
8. UPDATE MY PHYSICAL ADDRESS - This is the physical location of your business. Do not use a post office box for this address.
9. UPDATE MY PHONE NUMBER - Write your new phone number, including the area code in the spaces provided.
10. UPDATE MY EMAIL ADDRESS – Write your email address. Please provide your email address so the department may email license information and required notices to you. Your email address is confidential pursuant to the Texas Public Information Act, and the department will not share it with the public.
11. UPDATE MY ASSIGNED ELECTRICIAN - This section must be completed by your newly assigned electrician.
 - Do you own more than 50 percent of this contracting business? Check YES or NO to this question. As the business sponsor, if you do not own more that 50 percent of this contracting business, the following apply:
 - ◆ A licensed residential appliance installer can only be assigned to a single residential appliance installation contractor.
 - ◆ A licensed master sign electrician can only be assigned to a single electrical sign contractor
 - ◆ A licensed master electrician can only be assigned to either a single electrical contractor or a single electrical sign contractor
 - Carefully read the statement before sign and dating this section. Print your name and license number as it appears on your license issued by TDLR.
12. OWNER SIGNATURE - The owner must date and sign the request form. Changes to your business record can not be made if your request form is not signed by the owner.
