#### JOURNEYMAN LINEMAN LICENSE APPLICATION INSTRUCTIONS

DOCUMENTS SUBMITTED WITH YOUR APPLICATION WILL NOT BE RETURNED. KEEP A COPY OF YOUR COMPLETED APPLICATION, ALL ATTACHMENTS, AND YOUR CHECK OR MONEY ORDER.

#### MAKE CHECK OR MONEY ORDER PAYABLE TO TDLR.

- 1. NAME Write your legal name in the spaces provided. (Last, First, Middle Name, Suffix) Examples of a suffix include Jr., Sr., and II. (Mr. is not a suffix.) NOTE: The name you use on this application must match the VALID government–issued photo ID you intend to use to obtain access to the examination site.
- 2. DATE OF BIRTH Write your birthdate.
- 3. GENDER Select whether you are male or female.
- 4. <u>SOCIAL SECURITY NUMBER</u> Social Security number disclosure is required by Section 231.302(c)(1) of the Texas Family Code in order to obtain a license. Your social security number is subject to disclosure to an agency authorized to assist in the collection of child support payments. - MAILING ADDRESS Write your current mailing address. This is the address where we will send you mail. A post office box
  can be used as a mailing address. You can add the zip plus-4 to help the postal service deliver mail more efficiently and
  accurately.
- 6. PHYSICAL ADDRESS Write the physical address of your residence. Do not use a post office box for this address.
- 7. <u>PHONE NUMBER</u> Write a telephone number, including the area code, where we can reach you during the day. This may be your office phone number where we can leave a message.
- 8. <u>EMAIL ADDRESS</u> Write your email address only if you agree to the following statement. By providing my email address I authorize the Texas Department of Licensing and Regulation (TDLR) to send licensing communications and required notices to me by electronic mail. I understand that I may revoke this authorization in writing and that I must update my email address or I will not receive these notices. I understand that the email address I have provided in this application will remain confidential except as permitted or required by law.
- 9. CRIMINAL HISTORY Indicate if you have ever been convicted of, or placed on deferred adjudication for, any misdemeanor or felony, other than a minor traffic violation. If YES, complete and attach a Criminal History Questionnaire for each offense. This form can be obtained from the TDLR website at <a href="https://www.tdlr.texas.gov/MISC/lic002.pdf">www.tdlr.texas.gov/MISC/lic002.pdf</a>
  If you are worried your criminal history could prevent you from getting this license, Texas allows you to have your criminal history evaluated before submitting your application and non-refundable fees. To request a criminal history evaluation, submit a Criminal History Evaluation Letter, a completed Criminal History Questionnaire form for each crime you were convicted of, placed on deferred adjudication for, and a \$25 fee. - 10. <u>DISCIPLINARY ACTION HISTORY</u> Indicate if you have ever had an occupational license, certification, or registration suspended, revoked, or denied in any state. If you have, complete and attach a Disciplinary Action Questionnaire for each disciplinary action. This form can be obtained from the TDLR website at www.tdlr.texas.gov/misc/Disciplinary Action Questionnaire.pdf
- 11. LICENSING REQUIREMENTS You must have at least:
  - a. 7,000 hours of training in an apprenticeship program approved by the United States Department of Labor, OR
  - b. 3½ years of experience as a journeyman lineman for an electric utility, electric cooperative, municipally owned utility, or electrical contractor in this state.

When your experience has been approved, the agency examination provider will mail you a postcard with information on how to schedule your examination. The employment history portion of the application must include the full 3½ years. An Experience Verification Form is required for each employer. If you are using the apprenticeship program training, a certificate or letter from the U.S Dept. of Labor is required.

- 12. STATEMENT OF APPLICANT Carefully read the statement of applicant before you sign and date your application.
- 13. <u>EMPLOYMENT HISTORY</u> If you are applying for licensure by experience and examination, you will need to complete all portions of the employment history indicating your job duties. All areas of this document must be completed. An Experience Verification Form or letters on company letterhead must be completed and signed by a qualified individual. This form and the Employment History portion of the application must match.

  If you are licensed as a journeyman lineman by a municipal or regional licensing authority, you do not need to provide any experience with this application. Include a copy of your journeyman lineman license issued by the municipal or regional licensing authority. You must also include the "Discontinued Municipal or Regional Licensing Program Form".

#### <u>APPLICATION INFORMATION FOR MILITARY SERVICE MEMBERS, MILITARY VETERANS AND MILITARY SPOUSES</u>

The Texas Department of Licensing and Regulation recognizes the contributions of our active duty military service members, their spouses, and veterans.
