TYPE OF INSPECTION

FOUNDATION = Foundation inspections for the installation of industrialized housing and buildings - cannot perform the set or final inspection for industrialized housing and buil

INSTALLATION = Inspection of all aspects of the installation of industrialized housing or buildings, including the foundation, connection to the foundation, construction required to complete the structure, and all plumbing, mechanical, electrical, and energy compliance construction required to complete the installation. This will also include the construction of any porches, stairs, landings, carports, or other construction that affects the code compliance of the house or building.

INSPECTIONS OF SITE-BUILT REFS = All inspections associated with the construction of site-built REFS, including building, plumbing, mechanical, electrical, energy, etc.
