Master electrician license revoked for Central Texas work

AUSTIN – The Texas Department of Licensing and Regulation has revoked the master electrician license of a Quitman resident after he allowed someone else to perform electrical work using his license number and did not supervise the work as he is required to do by law.

Timothy D. Rike signed an agreed order revoking his license and also agreed to pay an administrative penalty of \$4,500. The revocation went into effect on Nov. 12, 2019.

Electrical contractors must either be a master electrician or must employ a licensed master electrician who will be responsible for supervising all electrical licensees who work for the electrical contractor. Allowing someone else to use a master electrician license is grounds for denial, suspension or revocation of an electrical contractor license.

A TDLR investigation found that:

- In November 2016, Rike allowed Centrair Electric to use his master electrician license to pull permits and perform electrical work at a location in **San Antonio**. Rike told TDLR investigators that he never went to the jobsite and did not know who had worked at the site, even though he was responsible for the work they performed.
- In December 2016, Rike allowed Centrair Electric to use his master electrician license to pull permits and perform electrical work at a location in **Austin**. Rike told TDLR investigators that he never went to the jobsite and did not know who had worked at the site, even though he was responsible for the work they performed.
- In March 2017, Rike allowed Centrair Electric to use his master electrician license to pull permits and perform electrical work at a location in **Boerne**. Rike told TDLR investigators that he never went to the jobsite and did not know who had worked at the site, even though he was responsible for the work they performed.

Rike cannot apply to have his licensed reinstated for at least one year.

TDLR maintains a public list of people whose licenses have been revoked, who have received cease-and-desist orders, or who have permanent injunctions issued against them, so that consumers can protect
