TDLR releases new list of revoked licenses

Complete TDLR list available online

AUSTIN – The Texas Department of Licensing and Regulation (TDLR) has released the newest list of people who are no longer authorized to perform or offer to perform licensed services in Texas. This latest list includes actions TDLR took in September and October to safeguard consumers and protect public health and safety.

TDLR suspended two tow licenses for companies located in Dallas and revoked a vehicle storage facility (VSF) license in Wichita Falls.

- The VSF license for Jody Wade Enterprises in Wichita Falls was revoked and a \$11,500 penalty assessed after the licensee used a vehicle stored at the facility without the vehicle owner's consent and failed to send a required notice to a vehicle title holder.
- The tow license for TK Towing in Dallas was suspended for one year and a \$5,000 penalty assessed. The company also was ordered to issue a refund to the vehicle owner mentioned in the order.
- The tow license for Longhorn Wrecker Inc. in Dallas was suspended for six months and a \$3,000 penalty assessed after the company performed an illegal tow.

TDLR also revoked the midwifery course license for Maternidad de Luz in El Paso. The school's accreditation as a midwifery education provider was withdrawn by the Midwifery Education Accreditation Council, so the school no longer met the TDLR requirements to be a provider.

The agency also revoked two massage establishment licenses and a massage therapist license for sexual activity:

- Perfect Salon & Spa LLC of Houston had its massage establishment license revoked for allowing an employee to engage in sexual contact in the establishment.
- A Plus Spa of Houston had its massage establishment license revoked for allowing an employee to engage in sexual contact in the establishment.
- The massage therapist license of Karsten Krummheiser of Universal City was revoked for engaging in sexual activity during a session with a client.

TDLR urges consumers not to hire unlicensed service providers because they can endanger your health and property. TDLR licensees have passed examinations checking their subject-matter expertise, they have been educated on Texas laws and rules and have undergone criminal background checks. Certain service providers also may have insurance to cover any damages that might happen while they are working on your property.

TDLR revoked several massage therapist licenses for engaging in sexual contact during treatment sessions, as well as several massage establishment licenses for allowing sexual contact to occur on the premises or allowing unlicensed individuals to perform massage therapy services.
