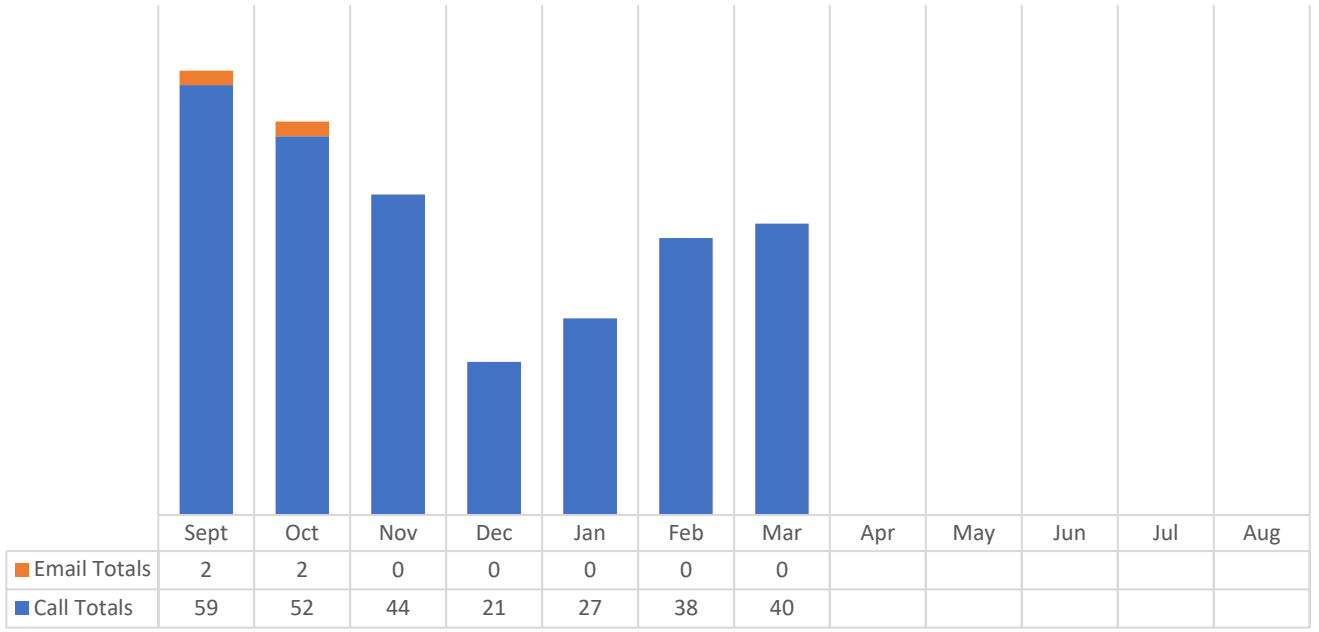

Case Highlights

ALEXIS R. ROSAS (TDLR Case No.: BOX20180001336)

On March 14, 2018 the Executive Director issued a default order against Ms. Rosas revoking his combative sports contestant license and imposing an administrative penalty of \$4,000. Respondent had, prior to a fight on August 5, 2017, tested positive for cocaine.

CNY PROMOTIONS, LLC (TDLR Case No.: BOX20170011764)

On December 19, 2017 the Executive Director issued an Agreed Order assessing an administrative penalty of \$750 for Respondent's failure to pay all deductibles and cover medical expenses for a contestant injured in a fight.

MATTHEW FOSTER (TDLR Case No.: BOX20180001348)

On January 31, 2018 the Executive Director issued a default order assessing an administrative penalty of \$3,000 and revoking Respondent's boxer license for positive test results prior to a bout for cannabinoid and cocaine.

ARTRIMUS SARTOR (TDLR Case No.: BOX20170017423)

On December 20, 2017 an Agreed Order was issued assessing Respondent an administrative penalty of \$750 as the result of test results showing the presence of cannabinoids at the time of a bout.

CLARENCE BROWN (TDLR Case No.: BOX20170018864)

On December 20, 2017 a default order was issued assessing Respondent an administrative penalty of \$1,000 and revoking his combative sports contestant license due to positive test results for cannabinoids and his failure to pay an administrative penalty of \$1,000 from a prior violation.
