PROPERTY TAX PROFESSIONALS BREAK IN SERVICE CREDIT APPLICATION INSTRUCTIONS

The application must be completed and signed by the applicant. An application is not considered complete and will not be processed until all required items have been submitted. All information provided must be typed or printed in black ink. Attachments must be submitted on separate pieces of single-sided, 8½" x 11" paper. Use a paperclip to fasten all pages together, with the check or money order on top. **Do not use staples.**

DOCUMENTS SUBMITTED WITH YOUR APPLICATION WILL NOT BE RETURNED. KEEP A COPY OF YOUR COMPLETED APPLICATION, ALL ATTACHMENTS, AND YOUR CHECK OR MONEY ORDER.

The break in service credit allows a property tax professional registrant to extend his or her five year certification date to include the time the registrant was not employed as a property tax professional. However, if the time unemployed as a property tax professional is greater than five years, you are not eligible for a break in service credit.

1. NAME - Write your name as it appears on your registration certificate.
2. REGISTRATION NUMBER - Write your PTP registration number and check your registration type.
3. ARE YOU EMPLOYED BY THE ELECTED COUNTY ASSESSOR-COLLECTOR - Check YES or NO to indicate if you are employed by the elected county assessor-collector. If YES, you are no longer required to register, and your application will be returned to you.
4. MAILING ADDRESS - Write your current mailing address. This is the address where we will send you mail. A post office box can be used as a mailing address. You can add the zip plus-4 to help the postal service deliver mail more efficiently and accurately.
5. PHONE NUMBER - Write a telephone number, including the area code, where we can reach you during the day.
6. EMAIL ADDRESS - Write your email address. Please provide your email address so the department may email license information and required notices to you. Your email address is confidential pursuant to the Texas Public Information Act, and the department will not share it with the public.
7. BREAK IN SERVICE DATES - Write the beginning and ending dates you were not employed as a registered property tax professional. Additionally, write the county that employed you before your break in service and the county that employs you now.
8. STATEMENT OF APPLICANT - Carefully read the statement of applicant before you date and sign your application.

3. I will not use information received in connection with the duties of an appraiser, assessor, or collector for my own purposes, unless such information can be known by ordinary means to any ordinary citizen;
4. I will not engage in an official act that is dishonest, misleading, fraudulent, deceptive, or in violation of law.
5. I will not conduct my professional duties in a manner that could reasonably be expected to create the appearance of impropriety;
6. I will not accept an appraisal, assessment, or collection related assignment that can reasonably be construed as being in conflict with my responsibility to my jurisdiction, employer, or client, or in which I have an unrevealed personal interest or bias; and
7. I will not accept an assignment or responsibility in which I have a personal interest without full disclosure of that interest.
