WELL DRILLER/PUMP INSTALLER APPRENTICE REGISTRATION INSTRUCTIONS

The application must be completed and signed by the applicant. An application is not considered complete and will not be processed until all required items have been submitted. Attachments must be submitted on separate pieces of single-sided, 8½" x 11" paper.

DOCUMENTS SUBMITTED WITH YOUR APPLICATION WILL NOT BE RETURNED. KEEP A COPY OF YOUR COMPLETED APPLICATION, ALL ATTACHMENTS, AND YOUR CHECK OR MONEY ORDER.

FEES

- **Initial Application Fee - Well Driller OR Pump Installer Apprentice Registration - \$65**
- **Initial Application Fee - Combination (Well and Pump) - \$115**

1. NAME - Write your legal name in the spaces provided. (Last, First, Middle Name, Suffix) Examples of a suffix include Jr., Sr., and III. (Mr. is not a suffix.)
2. DATE OF BIRTH - Write your birthdate. (You must be at least 18 years old.)
3. GENDER - Select whether you are male or female.
4. SOCIAL SECURITY NUMBER - Social security number disclosure is required by Section 231.302(1) of the Texas Family Code in order to obtain a license. Your social security number is subject to disclosure to an agency authorized to assist in the collection of child support payments. 5. MAILING ADDRESS - Write your current mailing address. This is the address where we will send you mail. This address can be a post office box.

HOME PHONE NUMBER - Write a telephone number, including the area code, where we can reach you during the day. This may be your office phone number where we can leave a message.

CELLPHONE NUMBER - Write your cellphone number, including the area code, where we can reach you during the day.

EMAIL ADDRESS - Write your email address. Please provide your email address so the department may email license information and required notices to you. Your email address is confidential pursuant to the Texas Public Information Act, and the department will not share it with the public.

PHYSICAL ADDRESS - Write your physical address. This address cannot be a post office box.

PHONE NUMBER - Write an alternative phone number where you can be reached if you have one.
6. REGISTRATION TYPE - Check the registration type for which you are applying.
7. CRIMINAL HISTORY - Indicate if you have ever been convicted of, or placed on deferred adjudication for, any misdemeanor or felony, other than a minor traffic violation. If YES, complete and attach a Criminal History Questionnaire for each offense. This form can be obtained from the TDLR website at www.tdlr.texas.gov/MISC/lic002.pdf.

If you are worried your criminal history could prevent you from getting this license, Texas allows you to have your criminal history evaluated before submitting your application and non-refundable fees. To request a criminal history evaluation, submit a Criminal History Evaluation Letter, a completed Criminal History Questionnaire form for each crime you were convicted of, or placed on deferred adjudication for, and a \$25 fee. 8. DISCIPLINARY ACTION HISTORY - Indicate if you have ever had an occupational license, certification, or registration suspended, revoked, or denied in any state. If you have, complete and attach a Disciplinary Action Questionnaire for each sanction. This form can be obtained from the TDLR website at www.tdlr.texas.gov/misc/DisciplinaryActionQuestionnaire.pdf
9. APPLICANT'S STATEMENT AND SIGNATURE- Carefully read the statement before you date and sign your application.

WELL DRILLER/PUMP INSTALLER APPRENTICE EXPERIENCE VERIFICATION FORM

This form must be completed by a licensed driller or pump installer who has supervised your work.

This is page two of the "registration application"; however, this form may also be used if a registered apprentice is changing supervisors.

10. WRITE APPLICANT AND SUPERVISOR'S NAME - Write the applicant's name and social security number. Write the supervisor's name and license number.
11. APPLICATION QUESTIONS: Answer the following questions on the application: Is this an original application, and is this application to transfer supervisory responsibility.
12. SUPERVISING LICENSE HOLDER QUESTION - Answer the question on the application: Have you held your driller/installer license for at least two years. (Note: The supervising driller/installer must have held their license for at least two years in order to supervise an apprentice.)
13. TRAINING AND EXPERIENCE: List the type of equipment the applicant used, the safety training the applicant is or has taken, and the procedures, experience and knowledge they have in this field.
14. SUPERVISOR'S STATEMENT AND SIGNATURE: The licensed supervising driller/installer is required to sign and date this form.
Note: The licensed supervising/driller must have held or hold a license for a minimum of two years in order to supervise an apprentice.
